
BigRock 2025 Black Friday Contest Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. CONTEST ENTRY IS VOID IF NOT ALLOWED BY LAW IN YOUR HOME JURISDICTION. ENTRY IS BASED ON ELIGIBILITY AT TIME OF PRIZE DRAW.

1. Sponsor

2. Eligibility

BigRock 2025 Black Friday Contest (the “Giveaway”) is open to legal residents of India who are at least eighteen (18) years old at the time of entry.

Proof of residency and age may be required.

4. In the entry you must do the following; tell us about yourself and a short description of the business that you currently own or a business idea that you look to establish in the future. Submit the form from the website contest page. Social publishing of this contest will be at the discretion of the participant and is not to be considered as a compulsion for the giveaway.

Limit one (1) entry per person throughout the giveaway. Any attempt by you to obtain more than the stated number of entries by using multiple/different identities, registrations and logins, or any other methods will be void and you and your entries will be disqualified. The potential Giveaway winners will be contacted privately via the email id used to enter the giveaway. The potential winners will be chosen by a judging panel comprised of “sponsor” employees who will judge the submitted ideas on various elements, including uniqueness and innovation of the idea and may be awarded the prize subject to verification of eligibility and compliance with the terms of these Official Rules. The potential Giveaway winner will be notified on the day of the drawing.
